

6.Membership:

Membership of association is open to all former students of JNV Periye

- (a) Application for membership shall be made in the prescribed form signed by the applicant accompanied by the requisite fee.
- (b) Membership in the association shall be of the following categories
- (i) Founder Member means those who took initiative in the formation of the association and paid Prescribed fee.
 - (ii) 'Life Members' means members who contribute a sum of Rs. 2000/- to the association.
- (iii) 'Ordinary members 'means members who contribute an amount of Rs.700/- (Admission fee of Rs.100/- + Rs.600/- membership fee) which have to be renewed every year
- (iv) 'Honorary Members' means the teaching staff of the JNV Periye.
- (c) Every member, other than honorary members shall have a right to vote in the meeting of the association.
 - (d) The Association shall maintain a Register of members and it shall be open to inspection by all Members.
- (e) A member may resign from the association with 15 days of notice.
- (f) The Ordinary member's shall lose their membership temporarily, if they default in the payment of Annual subscription for a continuous period of three years. Re-admission is at the discretion of Executive committee. In such case the fee for enrolment and membership has to be remitted. (Reregistration).

7. General Body Meeting

All the members of the association constitute the general body and the generalbody meeting of the members of the association shall be held annually on December of every calendar year to transact the following business.

- (a) Approval of audited Balance Sheet and Income and Expenditure Account of the association
- (b) Approval of the Societies Annual Report.
- (c) Election of members to the executive committee when such election falls due and the presentation of the new budget.
- (d) Suggestions and recommendations of the members regarding the policies of the association.
- (e) Consideration of such ordinary matters as approved by the President.
- (f) Amendments, if any, in the Rrules of the oif the association about which clear intimation is given through the notice for the annual general body meeting with a majority of 3/5 th of the members present.

(g) Notice u/s 10(f) shall have state the venue ,date and time of the meeting and also the agenda

for the meeting, including the audited Balance sheet and Income and Expenditure account and societies Report.

(h) Fifty percent of the members of the society may in writing and request for convening a special

General body meeting to consider specific issues. The Secretary shall convene a Special General body meeting within 30 days from the date of receipt of such requisition in consultation with executive committee.

(i) Quorum for any General body meeting shall be 10% of the total members of the association .

8. Governing Body(Executive Committee)

- (a) The Society shall be governed by a body of executive committee consisting of 7 members elected by the general body including President, Vice President, Secretary, Joint secretary and Treasurer.
- (b) The members of association shall be elected by the members of the general body in the Annual General body meeting according to the rules mentioned below.
 - 1. The members elected by the general body shall hold office for a period of Five years.
 - 2 . The members of the executive committee shall not be entitled to any remuneration.
 - 3 . The executive committee shall meet atleast once in three months.
 - 4 . Quorum for executive committee shall be 1/3 of the total members .
 - 5 . The executive committee shall be convened by the Secretary .
 - 6 . Proceedings of the executive committee meeting shall be recorded in the register maintained for such purpose .
 - A person who is not a member of the general body shall not be elected to the executive
 Committee.
 - 8 . Any vacancy in the executive committee arising out of death, insanity or resignation of a member may be filled up by the association.

9. Duties Of The Committie

- (a) Duties of the president: The president shall preside over all meeting of the societ
- (b) <u>Duties of the secretary</u>: Secretary is the chief executive officer of the society and Shall convene the meeting with the consent of the president. He /she shall be the custodian of all records and properties and shall discharge all administrative duties approved by the association.
- (c) <u>Duties of vice president</u>: In the absence the president the vice president shall Preside overall meetings of the socity. In the absence of the president and the Vice president, The President of the day shall be elected from among the members present.
- (d) <u>Joint Secretary</u>: In the absence of the secretary, the joint secretary shall discharge all the duties assigned to the secretary.
- (e) <u>Duties Of The Treasurer</u>: The Treasurer is responsible person to maintain all accounts in aproper manner.
 - (f) Power of the association: The affairs and properties of the society shall be visited in the executive committee and shall be subject to the supervision and control of the general body.
 - (g) The executive committee shall have powers and appoint staff and fix their terms of society.
 - (h) The executive committee shall have powers to incur necessary expenditure for Managing and carrying out the objective of the association.
 - (i) The Exe Committee shall have powers to open accounts with an scheduled cooperation or nationalized bank or banks, such account shall be opened by three members and operated by the treasurer and the president.
 - (j) The executive committee shall maintain all book of accounts.
 - (k) The association shall have powers to borrow funds receive donation to raise funds

according to the requirements of the association.

- (I) The association shall cause the accounts to be audited annually.
- (m) Every transaction of the society shall be decided in the meetings of the executive Committee or supported by a resolution validity passed subject to ratification in the meeting executive committee.
